Application

- Pour the contents of the sachet into the mixer or dry mix.
- 2. Add 1 sachet maximum per 25kg bag of cement.
- 3. With the machine mixing, Sealocrete Sealomix Powdered Mortar Plasticiser can be added at any stage.
- 4. Switch off machine during rest periods to avoid excessive air entrainment.
- Sealocrete Sealomix Powdered Mortar Plasticiser reduces the amount of water required in the mix. Adjust to achieve the required consistency.

 Clean tools and equipment immediately after use with water.
